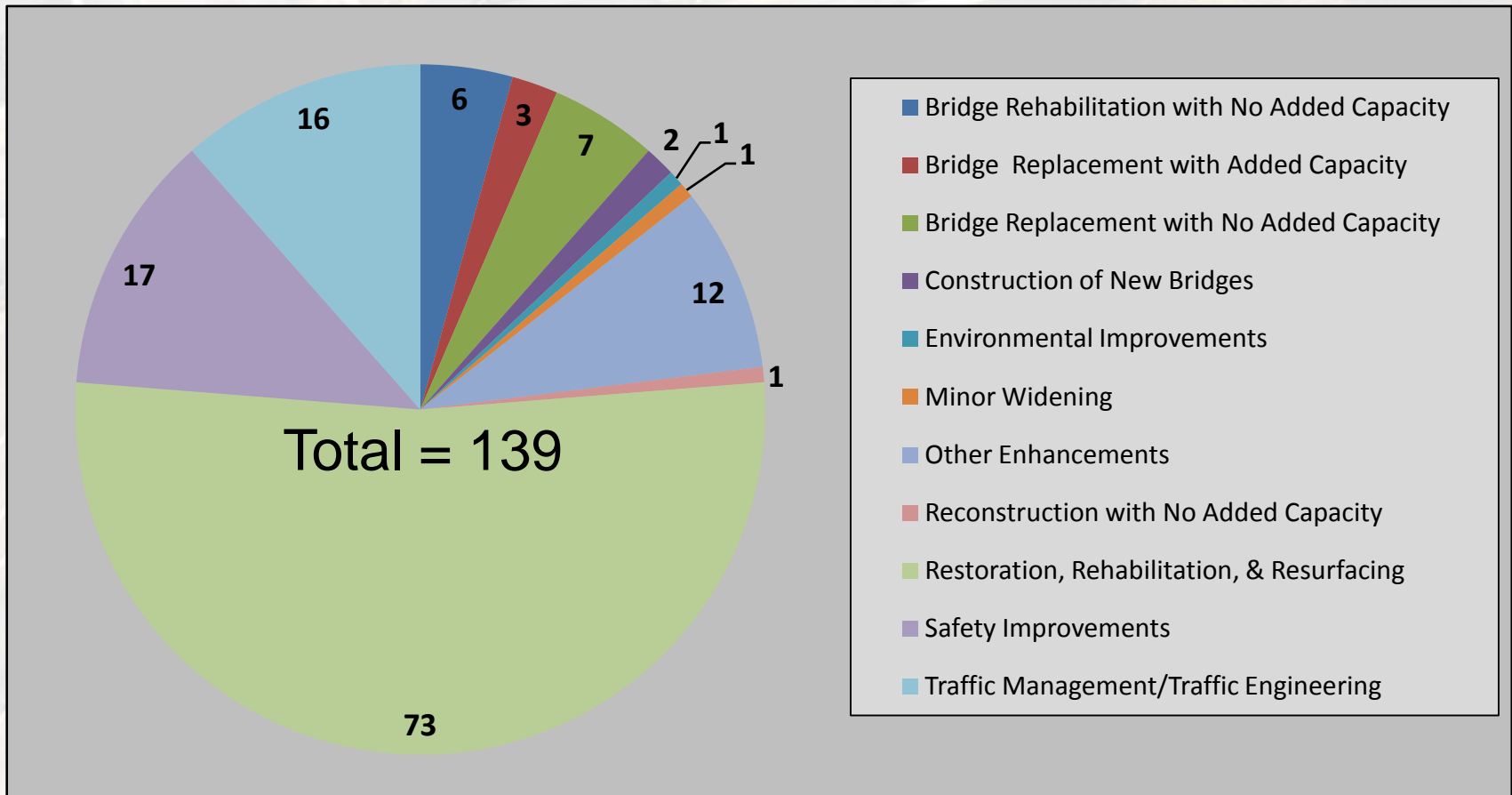

## Total Number of Projects Awarded to Date

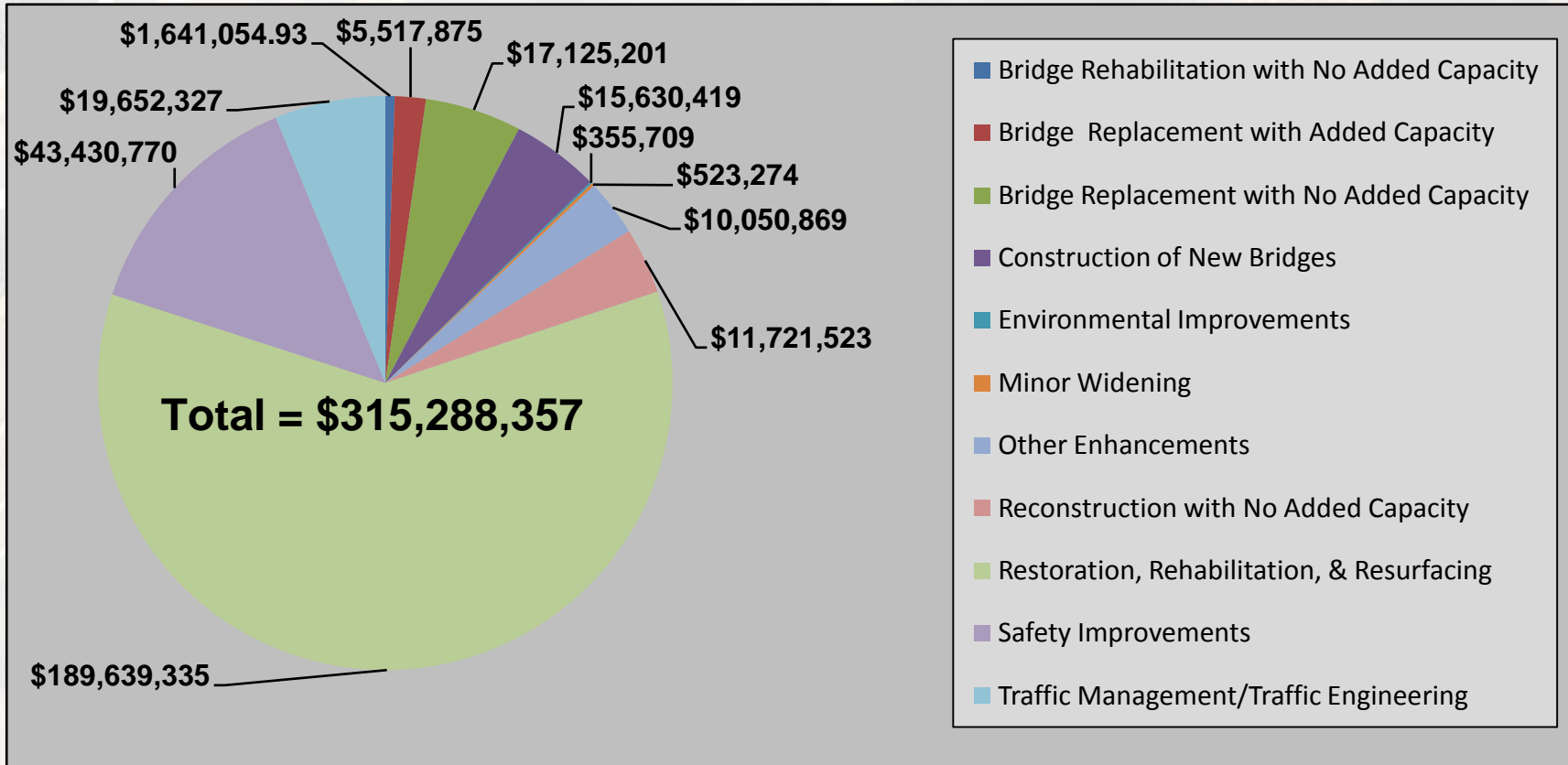

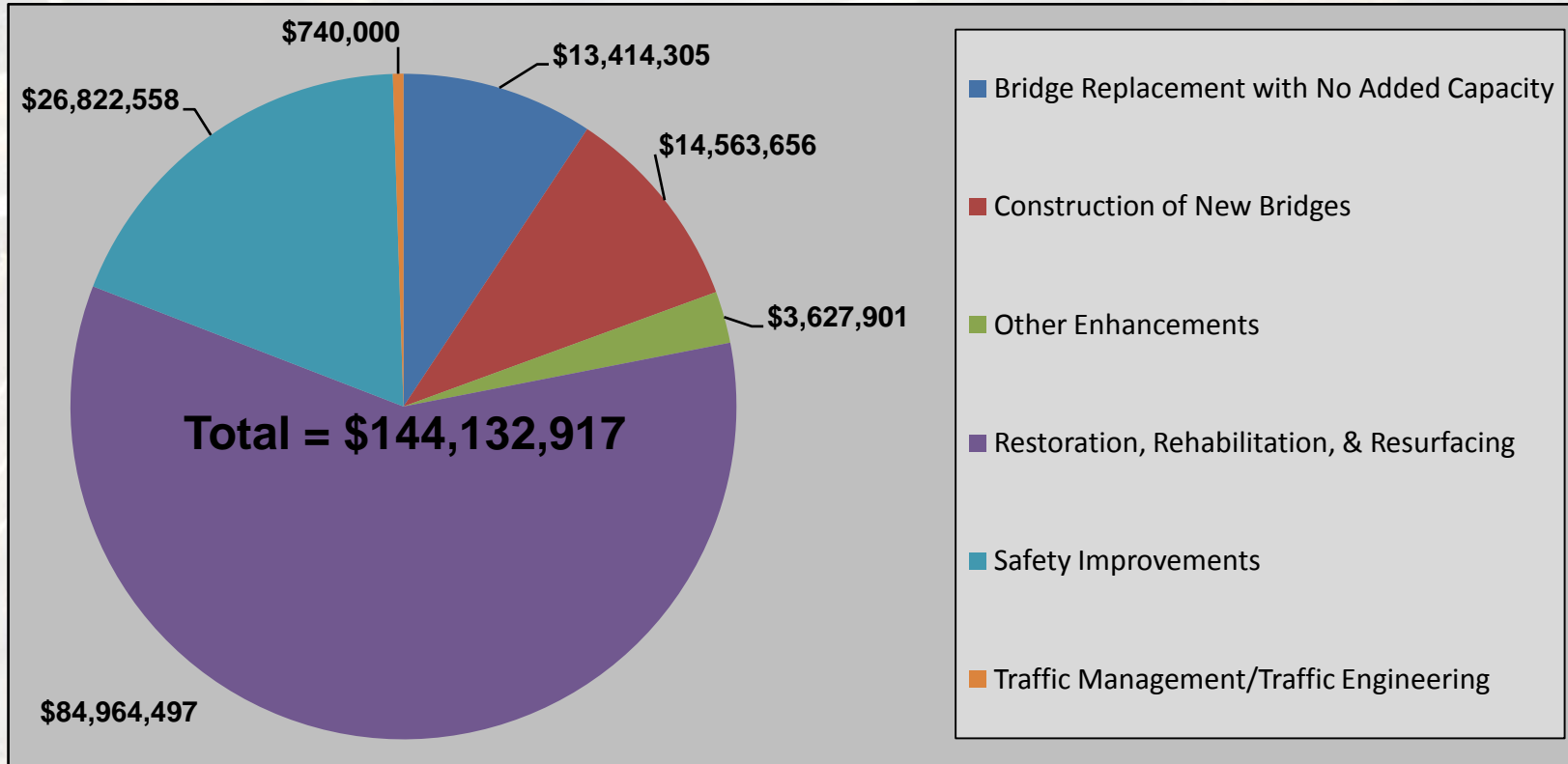

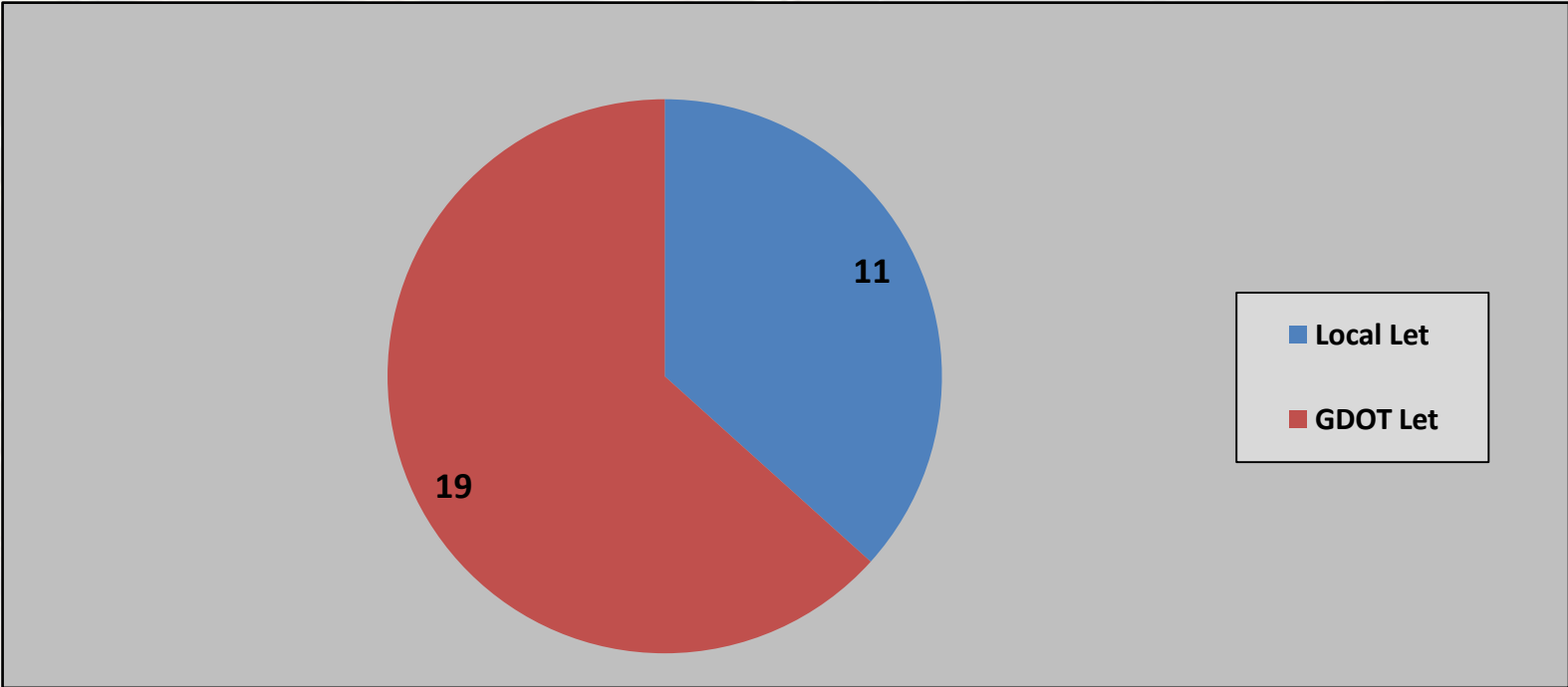
